

MATCHLIGHT SOFTWARE, INC.

COMPOSITE IMAGING SYSTEM LICENSE AGREEMENT

THIS IS A LEGAL AGREEMENT BETWEEN YOU ("LICENSEE") AND MATCHLIGHT SOFTWARE, INC., A WASHINGTON CORPORATION ("LICENSOR"). BY CHECKING THE BOX NEXT TO "I HAVE READ AND AGREE TO THE COMPOSITE IMAGING SYSTEM USE LICENSE" AND CLICKING THE "PURCHASE" **BUTTON** YOU AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT AND THE LICENSED MATERIAL USAGE SPECIFICATIONS SET FORTH HEREIN. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO NOT CHECK THE BOX NEXT TO "I HAVE READ AND AGREE TO THE COMPOSITE IMAGING SYSTEM USE LICENSE". THIS AGREEMENT APPLIES TO LICENSES ISSUED VIA THE WEB OR OTHERWISE AND IS APPLICABLE TO ONLINE, DIGITAL AND ANALOG (PHYSICAL) DELIVERY OF LICENSED MATERIAL. IF YOU HAVE ANY QUESTIONS, PLEASE CONTACT LICENSOR.

IF YOU ARE ENTERING INTO THIS AGREEMENT ON BEHALF OF YOUR EMPLOYER, THE LICENSE GRANTED AND RESTRICTIONS AND LIMITATIONS RECITED HEREIN APPLY TO YOUR EMPLOYER AND TO YOU AS A REPRESENTATIVE OF YOUR EMPLOYER.

1. Definitions

In this Agreement the following definitions apply:

a) "Licensee Images" means photographic images (foreground or background) created by Licensee using the Licensed Material.

b) "Licensed Material" means the Matchlight Composite Imaging System™ comprised of one or more of the the following components identified on the pre-printed or computer-generated receipt provided by Licensor: the Preview Images; the Smart Images™; the Software; the Third Party Software; the Targets; all media, hardware and equipment delivered to Licensee by the Licensor; and all upgrades, updates, modifications, substitutions, user manuals and other documentation in connection with any of the foregoing.

c) "Licensor Images" means the low resolution Preview Images and the high resolution Smart Images™.

d) "Preview Images" means any low-resolution still image or visual representation generated optically, electronically, digitally or by any other means, including any negatives, transparencies, film imprints, prints, original digital files or any reproductions thereof, which were created by Licensor and contain the Targets, for the sole purpose of conceptual layout (e.g., "comping" or "for placement only").

e) "Reproduction" and "Reproduce" include any form of copying or publication of the whole or a part of any Licensed Material, whether by printing, photography, photocopying, slide projection (whether or not to an audience), layout or presentation, use in a production process, electronic, digital or mechanical means, use as a reference by an artist or in an artist's illustration or by any other means. Reproduction further includes the distortion or manipulation of the whole or a part of the Licensed Material (for example, by computer, electronically, digitally by an artist or by any other means), even though the resulting Licensed Material may not appear to a reasonable person to be derived from the original Licensed Material. Reproduction also includes distribution in whole or in part of any Licensed Material via television, cable, telecommunications network or Internet transmission.

f) "Smart Images" means any high-resolution still image or visual representation generated optically, electronically, digitally or by any other means, including any negatives, transparencies, film imprints, prints, original digital files or any reproductions thereof, which were created by Licensor and contain the Targets.

g) "Software" means the Licensor's MatchLight Software v2.0 provided in machine readable object code and any accompanying documentation, as may be modified and delivered by Licensor from time to time.

h) "Targets" means the three MatchLight Light Targets™ of different sizes and colors to be used by Licensee when photographing Licensee's subject images.

2. Grant of Rights

a) Unless stated otherwise herein, Licensor grants to Licensee a worldwide, nonexclusive, non-sub licensable, non-transferable and non-assignable right to use the Licensed Material solely to create Licensee Images. Licensor further grants to Licensee the right to sublicense the Licensed Material, solely to the extent explicitly stated herein, to subcontractors of Licensee, for the sole purposes of creating Licensee Images, provided that such subcontractors agree to abide by the restrictions of this Agreement.

b) Notwithstanding Section 2(a) above, the Licensed Material may not be sublicensed, resold or otherwise made available for sale, use or distribution to third parties on a stand-alone basis, nor may the Licensed Material be used to create background images for sale, use or distribution to third parties.

c) **The terms specified in this Agreement shall not be modified without the express written consent of Licensor, and any attempt to modify the Agreement without such express written consent, or any attempted deviation from the terms thereof of this Agreement, shall nullify the representations and warranties made by Licensor hereunder and shall result in the revocation of the license granted herein.** Licensee shall not undertake any expanded use of the Licensed Material without the prior approval of Licensor and the payment of any additional license fee required by Licensor for such expanded use. Licensee shall promptly notify Licensor of any expanded use of the Licensed Material for which Licensee has not received Licensor's prior approval, and shall pay to Licensor any additional license fee required by Licensor for such expanded use. The rights and remedies of Licensor hereunder shall be in addition to, and not in lieu of, any other rights or remedies that Licensor may have at law or in equity.

d) Use of Licensed Material in a manner not expressly authorized by this Agreement (i) may constitute an infringement of the proprietary rights of Licensor or a third party and (ii) may result in Licensee incurring or being responsible for any damages resulting from any such use, including any damages resulting from any claims for infringement of the intellectual property or proprietary rights of Licensor or a third party.

3. Restrictions on Use of Licensor Images

a) Licensor grants no rights and makes no warranties with regard to the use of names, trademarks, trade dress, registered, unregistered or copyrighted designs or works of art or architecture depicted in any Licensor Images, and Licensee must satisfy itself that all the necessary rights or consents regarding any of the above, as may be required for Reproduction, have been obtained.

b) While Licensor makes efforts to correctly caption the subject matter of the Licensor Images, Licensor does not warrant that such information is accurate.

c) Pornographic, defamatory, libelous or otherwise unlawful use of Licensor Images is strictly prohibited whether directly or in context or juxtaposition with specific subject matter.

4. Restrictions on Use of Software

a) Licensee is granted the right to use the Software in object code form only. Licensee shall not sublicense, decompile, disassemble, reverse engineer, modify, change, prepare derivative works based on, or make or distribute copies of the Software except the extent provided for herein. Licensee shall not, and shall not attempt to, remove, circumvent, override any copyright notice, watermark, or other copy protection or access control mechanism or measure present in any part of the Software. Licensee shall not use the Software, nor permit it to be used, in any manner not expressly permitted by this Agreement.

b) The IGOR Pro 4 software included in the Software is a copyrighted software product owned by Wavemetrics, Inc. ("Wavemetrics"), which has been licensed to Licensor. Licensee's use of the Software is subject to the terms of WaveMetric's IGOR Pro 4 end user license agreement, a copy of which is available to Licensee upon request.

5. Copyright

No ownership or copyright in any Licensed Material shall pass to Licensee by the issuance of the license contained in this Agreement. Except as expressly set forth in this Agreement, Licensor grants Licensee no right or license, express or implied, to the Licensed Material. **Licensee shall provide applicable copyright notice and/or protection.** Upon demand, Licensee shall immediately assign to Licensor (or Licensor's designee) any copyright of or to the Licensor Images arising out of the publication of the Licensor Images. No copyright information shall be removed from any digital file.

6. Warranty and Limitation of Liability

THE REPRESENTATIONS AND WARRANTIES OF LICENSOR MADE HEREIN WILL HAVE NO FORCE OR EFFECT IF THE LICENSED MATERIAL IS USED BY LICENSEE IN ANY MANNER NOT SPECIFICALLY AUTHORIZED IN THIS AGREEMENT OR IF LICENSEE IS OTHERWISE IN BREACH OF THIS AGREEMENT.

a) Licensor warrants to Licensee that the Targets, the digital or analog copy of the Licensor Images and the Software in the form downloaded by Licensee or delivered by Licensor by any means to Licensee will be free from defects in material and workmanship for 30 days from the date of delivery. The sole and exclusive remedy for a breach of the foregoing warranty is the replacement of the Targets, the digital or analog copy of the Licensor Images or the Software, as the case may be, or refund of the applicable license fee paid by Licensee, at Licensor's option.

b) Licensor represents and warrants to Licensee that:

(i) It has all necessary rights and authority to enter into and perform this Agreement in accordance with its terms, including, but not limited to, the right and authority to license the use of any Licensed Material as expressly set forth herein, including the rights to license the copyrights in and to the Licensor Images and Software on the terms and conditions set forth in this Agreement;

(ii) The rights of Reproduction granted hereunder do not infringe on any copyrights to the Licensor Images and Software or moral rights of any person or entity;

(iii) All necessary property releases have been obtained by Licensor except where specifically stated in this Agreement, Licensor's website or other notice from Licensor;

(iv) A copy of any property release will be provided to Licensee upon request so that Licensee can satisfy itself as to the extent and validity of that release. Licensee understands and agrees that the personal information of that property owner will be redacted for the protection of the privacy of the property owner.

The foregoing representations and warranties apply only to the Licensed Material as delivered by Licensor when used in accordance with the terms of this Agreement and the uses expressly provided for herein.

c) EXCEPT AS EXPRESSLY SET FORTH IN SECTIONS 6(a) AND 6(b) ABOVE, LICENSOR MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. LICENSOR SHALL NOT BE LIABLE TO LICENSEE OR ANY OTHER PERSON OR ENTITY FOR ANY GENERAL, PUNITIVE, SPECIAL, DIRECT, INDIRECT, CONSEQUENTIAL, INCIDENTAL, LOST PROFITS OR OTHER DAMAGES ARISING OUT OF THIS AGREEMENT OR OTHERWISE, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

7. Indemnification

a) Licensee agrees to indemnify and hold Licensor (including its parent, affiliate and subsidiary companies and their respective directors, officers, employees and agents) harmless against any claim for damages, losses or any costs, including attorneys' fees, arising in any manner whatsoever from the unauthorized use of any Licensed Material or for Licensee's breach of any of the terms of this Agreement.

b) Licensee shall defend, indemnify and hold Licensor and its parent, subsidiaries, and commonly owned or controlled affiliates and their respective officers, directors and employees harmless from all damages, liabilities and expenses (including reasonable attorneys' fees and costs), arising out of or connected with any actual or threatened lawsuit, claim or legal proceeding alleging that the possession, distribution or use of Licensee Images by Licensee results in an invasion or infringement of the following intellectual property or persona rights of any third party:

(i) Invasion or infringement of the right of privacy or publicity, including but not limited to, the torts of intrusion into one's private affairs, public disclosure of private facts, false light, misappropriation of the name or likeness arising as prescribed by applicable law;

(ii) Copyright infringement; and

(iii) Product disparagement, trade libel, dilution or infringement of title, slogan or trademark, trade name, service mark or service name as prescribed by applicable law.

8. Parties' Obligation

Upon notice from Licensor, or upon Licensee's knowledge, that any Licensed Material is subject to a threatened or actual claim of infringement, violation of another right, or any other claim for which Licensor may be liable herein, or if Licensor retires any Licensed Material for any reason, Licensee will physically remove the Licensed Material from its network, if possible, and cease any future use at its own expense. Licensor shall provide Licensee with comparable Licensed Material (which comparability will be determined by Licensor in its reasonable commercial judgment) free of charge, but subject to the other terms and conditions of this Agreement.

9. Electronic Storage

For all Licensed Material that Licensee takes delivery via download or other form of electronic delivery, Licensee must provide the copyright symbol, the name of Licensor and the Licensed Material identification number as part of the electronic file. In addition, Licensee may only use a single copy of the Licensed Material on a single computer. Licensee may only download the Licensed Material onto one (1) computer hard drive or other computer medium and may not otherwise make, use or distribute copies of the Licensed Material for any purpose except as otherwise provided in this Agreement. Notwithstanding the foregoing, Licensee shall be allowed to make one (1) backup copy for security reasons only. Licensee may not use the Licensed Material on any image storage jukebox, network configuration or similar computer network arrangement. Upon the expiration or earlier termination of this Agreement, Licensee shall promptly delete the Licensed Material from its computer or other electronic storage system.

10. Condition of Licensed Material

Licensee should examine all Licensed Material for possible defects (whether digital or otherwise) before sending any Licensed Material for Reproduction. Licensor shall not be liable for any loss or damage suffered by Licensee or any third party, whether directly or indirectly, arising from any alleged or actual defect in any Licensed Material or its caption or in any way from its Reproduction.

11. Use of Licensor Images in Final Elements

For purposes of this paragraph, final elements shall mean any end product produced by Licensee pursuant to this Agreement, including but not limited to the Licensee Images and the use thereof in magazines, books, feature films, television productions, commercials and print advertisements ("Final Elements"). Licensee grants to Licensor the worldwide, irrevocable, perpetual, royalty-free, non-exclusive right and license to use Final Elements solely for the promotion of Match light Software, Inc. or any of its subsidiaries or affiliates.

12. Right to Information

Licensor may at any time inspect any records, accounts and books relating to the Reproduction of any of Licensed Material to ensure that the Licensed Material is being used in accordance with this Agreement.

13. Miscellaneous Terms

No variation of any of the terms in this Agreement shall be effective unless agreed to in writing by an authorized representative of Licensor and Licensee. No part of the content of Licensor's catalogs, web page or other advertising materials shall form a part of this Agreement. No action of Licensor, other than an express written waiver, may be construed as a waiver of any term of this Agreement. A delay on the part of either party in the exercise of its rights or remedies will not operate as a waiver of such rights or remedies, and a single or partial exercise by a party of any such rights or remedies will not preclude other or further exercise of that right or remedy. A waiver of a right or remedy on any one occasion will not be construed as a bar to or waiver of those rights or remedies on any other occasion. Should any clause of this Agreement be found unenforceable, that will not affect any other clause and each will remain in full force and effect. **In the event of any inconsistency between the terms contained herein and the terms contained on any purchase order sent by Licensee, the terms of this Agreement shall govern.** This Agreement, its validity and effect, shall be interpreted under and governed by the laws of the State of Washington, U.S.A., without reference to its laws relating to conflicts of law. Except as otherwise set forth herein, venue for all disputes arising under this Agreement shall lie exclusively in the Courts in the State of Washington or the Federal District Court of the Western District of Washington (as permitted by law) and each party agrees not to contest the personal jurisdiction of these courts. Notwithstanding the foregoing, Licensor shall have the right to commence and prosecute any legal or equitable action or proceeding before any non-United States court of competent jurisdiction to obtain injunctive relief or other relief in the event that, in the opinion of Licensor, such action is necessary or desirable.
